The records being requested are not pursuant to a FOIA request but rather this request is being made pursuant to the Department's investigatory authority under the Act. Therefore, do not notify the Contractor of this investigation or of the fact that an inquiry is being made by the Department into the project. You should not contact the employer regarding this investigation, and you should not request any records from the contractor under investigation or any contractor involved with the project. Any contact with any contractor involved with the project after receipt of this letter will interfere with this investigation.</p> <p>The Department is seeking certain information concerning compliance with the wage, notice and recordkeeping requirements of the Act by Dax Kirchoff Decorating (herein referred to as "Contractor). Copy of the contracts for the above named project; 5. Copy of the Contractor's bond; 6. Contracting firm's name, address, contact person, and phone number; 7. Copy of the Contractor's Certified Payroll. 8. Identification of all sources of funding used to pay for the project. In addition, if the project has been designated as a Davis Bacon Project, please provide a copy of the specific designation your public body received along with source of designation and funding. <p>If you have not received a Certified Payroll or any of the other requested documents from the Contractor, please provide IDOL with a written statement to that effect and do not request the Contractor provide Certified Payroll or any other records to you in order to comply with this request.
