## Question 1:

Under section 3.18 it states: "Labor: Contractor must be the primary contractor for the work performed and shall provide owner a list of Ten (10) references of similar projects in the Illinois area that they have performed." Does this mean that we need to provided references from the Illinois area only or could we bid on this project even though we are vendors from Florida? Could we bid on this project even though we are not licensed in the state of Illinois?

# Response 1:

References do not have to be from Illinois. Yes, you can bid on the project even though you are not licensed in the state of Illinois.

#### Question 2:

In reviewing your RFP, you included photos of the signs that are to be removed, but do you have the sizes of those signs? If you do not have the sizes of the signs to be removed may I come to your site and take those measurements? In cases where the signs are either monument, pylon or ground signs, is the expectation that the existing foundation may stay in place? If not, and we are to remove them can you provide drawing showing what the size is those foundations. Typically we leave foundations in place and ground them down to 6" below grade and cover with dirt. Would this be acceptable? Are the signs that are to be lit to be lit with LED's? What material thickness for the aluminum faces and cabinets are you expecting? Do you have surveys showing existing utilities or are we to include a private locator to determine the location of the on-site utilities?

\*Note the above noted sign dimensions are approximate and it is the responsibility of the contractor to visit the site prior to submitting a bid to verify existing conditions. The signs and their foundations all need to be removed in their entirety and the voids will need to be filled with soil and topped with turf seed and blanket, unless a new sign is to be located in the same location as the removed sign. Yes, the signs that are to be lit shall be lit with LED's. The sign faces and cabinets should be .090 Gauge Aluminum. The contractor is responsible for contacting J.U.L.I.E. for utility locations in the general location of each sign that is to be grounded mounted.

Alternative Line Item 2: Do you want a labor included (installed) unit price for 600 Linear Feet of Wire and Conduit? Or just a material price?
