#### 8. PRESIDENT'S REPORT: DR. CLINTON GABBARD

#### New Grant to Expand Access to Workforce Training for In-Demand Industries

Dr. Gabbard informed the Board that MCC has received the Strengthening Community Colleges Training Grant from the U.S. Department of Labor (DOL) to boost access to workforce training and skills development in high-demand manufacturing fields. The Strengthening Community Colleges Training Grant provides funding to meet the skill development needs of employers while also equitably supporting students in obtaining good jobs in in-demand industries. MCC received funding as a member of the Northern Illinois Advanced Manufacturing Pathways for Equity and Diversity (AMPED) project, which also includes lead applicant Rock Valley College and Highland Community College. Together, the three colleges will serve an estimated 700 students over the next four years, with a particular focus on encouraging women and students of color to complete training in advanced manufacturing and enter a career pathway at a family-sustaining wage.

### Celebrating the MCC Women's Tennis Team

The 2023-24 Women's Tennis team won the NJCAA Region 4 Tournament in October, which qualifies them for the NJCAA D1 National Tournament. The tournament will be held in Tyler, Texas on May 3-8 at Tyler Junior College. Seeding brackets for the tournament have not been set yet and will be announced on May 2. Head Coach Jim Stockwell has done an exceptional job leading our MCC Scot Women's Tennis team:

#### **Science Olympiad Illinois Individual Tournament**

The 2023-24 Illinois Science Olympiad season ended on a new high note this past Saturday, April 20 with dual concurrent State tournaments. The Illinois Teams State Tournament was held, as always, at the University of Illinois for those high schools who, at their Regional Tournament, earned a bid to State based on their overall Team Score. The brand new, precedent-setting Illinois Individual State Tournament was simultaneously run here at MCC and hosted by the Liebman Institute for Science Innovation with the support of veteran Science Olympiad coach and director Carlos Garrison. This tournament is the first of its kind in the nation and aims to equalize opportunity for individual STEM students receiving a medal in their event at Regionals, but whose overall team score was not robust enough to earn a bid to the State Teams Tournament. More than 300 students, 50 coaches and almost 40 schools converged on our campus to compete in 23 separate events at the State level, many of them making the long trip up from Southern, Western, and Central Illinois. Canton High School in west-central Illinois organized an in-school parade for their State Finalists and posted it on their social media. Durand High School whose students took multiple medals in multiple events said that this tournament was going to launch their science program and finally put them on the map. Truly, Illinois' best and the brightest in each event were allowed the chance to prove themselves!
